Terms and Conditions

Welcome to the Terms and Conditions for the Cultura First Birthday Global Connections Competition (**Competition**).

We're excited that you are interested in participating in this Competition. As with any competition, you'll need to adhere to a few things that we've outlined below. If you're not able to comply with these terms, unfortunately we have the right to disqualify you or declare your entry ineligible so it's important to take note of these terms.

1. The Terms and Conditions of this Competition are governed by the laws of the State of Victoria.
2. The Competition is being run by Multicultural Community Services Geelong Inc. trading as Cultura (ABN 71 355 229 834) of 100 Weddell Road, North Geelong, VIC 3215 (**we, us, ours**).
3. The Competition commences at 9:00am Australian Eastern Daylight Time (**AEDT**) on Saturday 18 March and closes at 12:00pm AEDT on Tuesday 28 March (**Competition Period**).
4. This competition is only available in Victoria, Australia.
5. To be eligible to enter the Competition you must:
 - 5.1. be an Australian citizen or resident;
 - 5.2. ordinarily reside in Victoria, Australia; and
 - 5.3. be over the age of 18.
6. Entrants may not be Directors of Cultura or members of the Executive Team of Cultura.
7. To enter, you must submit in 25 words or less stating why you deserve to make global connections during the Competition Period.
8. Entry is limited to one entry per entrant. If you submit more than one entry, only the first entry will be valid.
9. By entering, you agree that, without limitation:
 - 9.1. you are responsible for the content of your entry and for ensuring that the entry complies with these Terms and Conditions;
 - 9.2. the content submitted is your own, or you have consent to the use the content for the Competition;
 - 9.3. you will not submit material that is unlawful or fraudulent, that is in breach of any intellectual property, privacy, publicity or other rights, defamatory, obscene or derogatory;

- 9.4. you have complied with all applicable laws and regulations, including without limitation, those governing copyright, content, defamation, privacy, publicity and access to or use of others' computers or communication systems;
 - 9.5. you have the full rights to grant to us the rights referred to in these Terms and Conditions; and
 - 9.6. you will indemnify us against all costs and claims by third parties arising from a breach of these Terms and Conditions.
10. We reserve the right, at any time, to verify the validity of entries and entrants (including their identity, age and place of residence) and to disqualify anyone who submits an entry that is not in accordance with these Terms and Conditions.
 11. This Competition is a game of skill. An independent marketing team appointed by Cultura as the judging panel will choose the best entries via a de-identified process taking into account the creativity and originality of the entries. The final decision as to the winner will be made by Directors of Cultura on recommendation from the judging panel.
 12. Our decision in relation to any aspect of the Competition will be final and binding on all entrants. No correspondence will be entered into. We may, in our absolute discretion, decline to award any or all of the prizes if there are no entrants who meet the entry conditions.
 13. There will be one (1) prize of two return flights in economy class to any country of the winner's choice. The winner will be reimbursed for the cost of the two (2) return flights up to the amount of \$6,600 including GST. The winner must provide Cultura with a valid tax invoice from a registered travel agent or airline. Please allow at least 28 days from the date the winner provides the valid tax invoice to Cultura for the payment of the reimbursement.
 14. The total prize value is \$6,600 (including GST).
 15. The winner will be announced by Close of Business AEST on Wednesday 5 April online , on the website, and via email. You are not required to be present at the announcement.
 16. We will contact the winner within seven (7) working days of the announcement by phone or email through the details given to enter the Competition.
 17. If the winner does not respond to claim the prize within thirty (30) Calendar days of the draw, the next eligible entry as per clause 11, will be awarded the prize within sixty (60) calendar days of the original announcement date. We will continue to re-judge in the same manner until the prize has been claimed.
 18. The prize is not redeemable for an alternative prize or cash.
 19. The prize is not transferrable and must be redeemed by the winner.
 20. The winner's name will be published on our website and through our social media channels. By accepting the prize, the winner grants us permission to use their full name and suburb on our website and social media channels.
